BIRTH PARENT SERVICES

Placing nearly 1,200 children into loving, adoptive homes in our more than 55 years of service to our Colorado community.

- Free services to women in unintended pregnancies
- Services offered regardless of age, race, or religion
- Services include professional counseling and emotional support, referrals for medical care, housing, food, and clothing, pregnancy-related financial assistance toward meeting medical and/or living expenses
- Free parenting skills counseling
- Free adoption services

ADOPTION SERVICES

A source of hope for Christian couples who are unable to have children biologically and who dream of becoming parents.

- Licensed in the state of Colorado since 1964
- Domestic, infant adoption services to families across the U.S.
- Adoption Programs: Traditional, Designated, and Contract
- Adoption Services: training seminars, adoptive family home studies and updates, post-placement supervisory services, birth parent counseling and relinquishment, foster care, and finalization services
- Adoption fees are charged to adoptive families

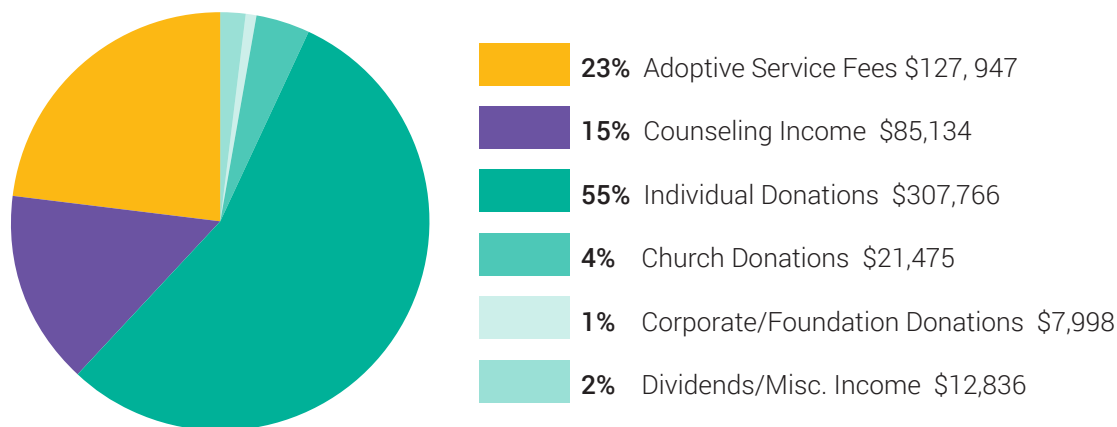

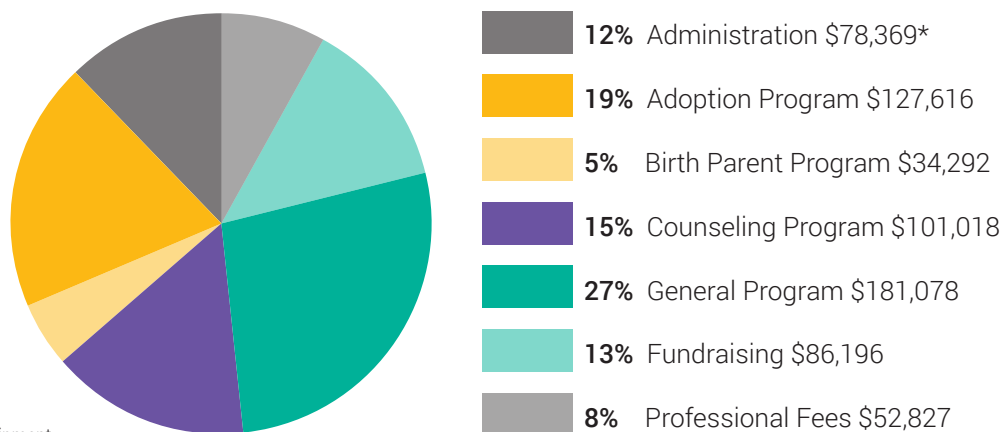
2020 REVENUE
