Since the beginning of our ministry in 1963, Colorado Christian Services has placed approximately 1,200 babies into loving, stable Christian homes. We are licensed in the State of Colorado and serve families across the United States. These services include: traditional and designated adoptions, contract services, adoptive family assessments and updates, birth parent counseling, and post-placement supervisory services. Adoption fees are charged to adoptive families for services rendered. In 2022, there were 152 adoptive families served, 19 families in process, one adoptive family assessment approved, 19 family assessment updates, and six adoptive placements.

4b (Code:) (Expenses \$ 908. including grants of \$) (Revenue \$) In 2022, 47 families received diapers, infant clothing, and other assistance through our Community Resource Room. There were 56 visits at the Community Resource Room in 2022.

4c (Code:) (Expenses \$ 137,204. including grants of \$) (Revenue \$) In 2022, Colorado Christian Services served 51 birth parents and opened 15 new birth parent cases. Colorado Christian Services provides free services to any pregnant woman, regardless of age, race, or religion. Our capable staff offers professional counseling and emotional support, as well as referrals for medical care, housing, food, and clothing. Depending on the birth mother's situation, we may also provide pregnancy-related financial help toward meeting medical and/or living expenses. For the birth mother deciding to parent, we offer parenting skills counseling. Should a client choose to place her child in a loving Christian home, we offer full adoption services.
